- In implementation phase









### Background on Engaging State Legislators

- Interviews and focus groups with 50+ state legislative leaders and education chairs on K-12 education policy
- Bi-partisan and nationwide
  - How do legislators view their role in education? What are their priorities?
  - Where do legislators get information about education? What factors influence their thinking on these issues?
  - How do they get things done? What are the roadblocks to change?

### What context do state legislators operate in?

- Expanded state role in education over the past 30 years shared with state board, governor, chief, and education agency
- Increasingly politicized environment
- Limited time and high turnover rate
- Incremental nature of the legislative process

"We have about seven weeks to get it all done. We really do finish it up in 45 calendar days."


#### How do legislators view their role in education?

- Preparing a workforce for future economic prosperity
- Getting a return on public investments
  - Questions on how to measure outcomes via assessments
- Lack of clarity on balance of federal, state, and local powers
  - Tension between accountability and micromanagement

"How do you run a classroom from the capitol?"

"For every legislator, education ends up being key to them because so much money goes there."

### How do legislators make decisions about education policy?



"I meet with superintendents, school boards, local teachers, parents. I take what the first three say with a grain of salt because, at the end of the day, they all want more money, and no amount will be good enough."

### What do legislators see as barriers to change?

- Complex intraparty and cross-chamber dynamics
  - Party not always an effective indicator of legislator's views on education
- Politicization and highly-charged debate
- Fatigue and lack of clarity around "reform"
- Perception that change is unpleasant for adults enacting it

"So much of what we do is to maintain the status quo for the adults."

### How can parents, educators and advocates engage legislators?

- Start with values and principles
- Build trust
- Share successful examples
- Invite them to your classroom
- Offer hands-on experience



### Opportunities to Engage Policymakers under ESSA

- Stakeholder engagement mandated for development of state plans, state report cards, district plans, school support and improvement plans, and activities funded by Title I – but engagement should not be a one-time check-the-box activity.
- Districts must set aside at least 1% of Title I funds to support parent and family engagement activities
- Grants available to state organizations to manage statewide family engagement centers (Title IV)
- Engage state policymakers to take advantage of new opportunities created by ESSA
  - E.g., Preschool Development Grants, weighted student funding pilot, assessment innovation pilot, high school assessment flexibility, and teacher evaluation flexibility
