

U.S. Employers Add 145,000 Jobs in December

Latino Unemployment Rate remained unchanged at 4.2%



RETAIL SERVICES EMPLOYMENT LEADS JOB GROWTH, ADDING 41,000 JOBS

In December, the retail services sector added 41,000 jobs. Latinos are overrepresented in the retail services sector, making up 17.7% of workers.

Employment of Latinos in December 2019

The U.S. Department of Labor (DOL) reported that employers added 145,000 jobs in December—a significant decrease from the 266,000 jobs added in November. Moreover, many of these gains are attributable to temporary or seasonal employment during the holidays. The national unemployment rate remained unchanged at 3.5% while the number of employed persons increased by 267,000 to 158.8 million.

The Latino unemployment rate remained unchanged at 4.2% from November to December. At 4.2%, the Latino unemployment rate is significantly higher than the national rate of 3.5%—a difference of 0.7%. In December, Latinos saw a slight decrease in those employed (-53,000), but also a slight decrease in the number of unemployed (-5,000).

Despite high labor force participation, many Latino families continue to struggle to cover basic necessities. One contributing factor is insufficient wage growth, an important indicator of job quality and a key factor in economic security. Over the past year, average hourly earnings only rose by 2.7%, compared to the 3.5% to 4% economists recommend for a healthy economy.

The following takes a closer look at Latino employment by gender and age:

- Men (ages 20 years and older): The Latino male unemployment rate remained unchanged at 3.0% from November to December. The number of employed Hispanic men decreased by approximately 105,000 between November and December.
- Women (ages 20 years and older): The unemployment rate for Latinas increased from 4.3% in November to 4.5% in December. The number of employed Hispanic women increased by 61,000 last month.
- Young Hispanic workers (ages 16–19 years old): The unemployment rate for Latino youth decreased between November and December from 16.5% to 14.2%.
